Note # This includes excess provision for gratuity amounting Rs. 1107665 (Rs. One Crore Ten Lakh Seventeen Thousand Six Hundred Fifty-Five) made in Sahibabad unit of the company earlier in the financial year of 2019-2020 has now been written back as it is no more required. This includes Rs 65757975/- (Rs. Six Crores Fifty-Seven Lakhs Fifty Seven Thousand Nine Hundred Seventy Five Only) pertaining to the provision for salary and benefits claimed by 23 employees of Sonapat Unit for the period from 1st January, 2020 to 6th December, 2022 in the Court of Sri Sunil Nandani, Authority under the Payment of Wages Act, 1936, Circle-1, Sonapat. The Company disputed the claim based on the fact NO WORK AND NO WAGES as Sonapat Unit was sealed by Municipal Corporation, Sonapat, and the operations of the unit remained closed, with no attendance of these employees. Since, the claim applications filed by the above said employees have been disposed of by the Adjudicating Authority without giving any relief, on account of which the company has reversed the said provision. Some of the employees have now gone to NCLT, Delhi, where no interim relief has so far been granted. In view of the above, the company management has decided to consider this liability as contingent liability only, pending Court adjudication.
